Financial Report

September 2019 Financials/Highlights (Geetha Huma)

- The average ADA is currently 290 students, slightly higher at 286 students
- Revenue is forecasted at \$3.8M, there are no significant changes from last month's projections for the last year
- Expenses are forecasted at \$3.6, approximately \$43K less than budget
- NHCA surplus forecasted at \$189K, ending fund balance forecasted at \$681K for the fiscal year
- An increase in full-time substitute teachers has NHCA spending \$7K for this quarter
- NHCA salary reductions have less teachers on staff \$10K
- Additional cutbacks in textbooks and supplies and technology were made by 25% \$39K

Mr. Thomas - NHCA have two very sizable expenses,

- The purchase of a Smart Board for 8th grade at Fair Avenue
- In addition, NHCA must provide transportation for one of our students, also at Fair Avenue

After School Programs
