Financials - Geetha will present the 2020 financial and our unaudited information

Geetha- will begin with (needs to connect to audio) Let's look at unaudited fiscal reports.

Geetha will share her screen Consolidated funding.

Overall revenue 200k less than projected Special ed. Expenditures- very expensive. Legal and consulting expenses.

Substitute teacher expenses were up.

Richard thomas- comments- we had a few cases to deal with- due process. Increases in our expenses. Compensatory minutes that needed to get done related to those cases. **Explains the higher expenditures

Geetha- highlights. 360k in cash. Not including PPP loan

RT- SB740- we have a split campus. 100 are at the Fair campus. What we anticipate- wouldn't have included those. Have we adjusted for this year.

Overall- special education, savings in payroll, and savings in school closures because of books Cash-360K at the end of the school year.

Geetha- any questions? We can approve the unaudited or move to the next subject.

Duran- question. What money came in July? Geetha- The PPP loan came in July. It was expected at the end of the year but came in July-the new fiscal year.

Learning loss funds- spend it before Dec. 30- will get paid in the next two weeks- a budget by sept 30- 262K

349K including early funds.

PPP not included in here. 380K to the PPP- added to the cash.

Non capitalized equipment- book and supplies: full amount for the federal relief funding as a placeholder.

CARES act round 1 Learning Loss Mitigation

Share the budget for this loss mitigation - she will send a list Technology, software, professional development- sending the list for what is being used.

853K- financing- 12-15 months until all state funding is received. 21/22- you will see the repayment

Interest Expense- that is 30K for 800k approx. Nov 2021- All debt should be paid by then.

Some of the things that we are working on.

RT- contract with Deltch under our E-rate- they will also provide support for many of our more local issues./ tech support.

Price with deltech- becoming a major expense. 1500 dollar a month contract that will service all of our needs. Technicians are available to deal with all of this. This will also include repairs.

This is also being covered by loss mitigation funds.

Prop 39- we have access. Exclusive use if they need to use them. Cost was adjusted because we are not using some of the shared use. Coming down to 6k

We are concluding our meeting. We are off to a great start. We appreciate the board's support. We are gearing up and giving 120 meals each day. All of our TAs are helping teachers. This is the update of our instructional program.

If anything changes- if we were to go hybrid in dec/ jan there if there is a flare up- the board allows him to make that decision before everyone can meet. This allows for quick change.

Anticipating some of the things that may happen in winter.

We appreciate your support.

We have great teachers that work with the kids. We have a great team. It's been a great collective effort.
