Monthly Financial Report

May 2021 Financials

- 1. Average Daily Attendance at The average ADA is 267, down from 272 last year, for an average daily attendance of 90.8%.
- 2. Revenue is forecasted at \$4.6MM, decreased from last month. Mainly due to prior state funding adjustments mainly due to Payroll Protection Program (PPP) loan forgiveness \$374K
- 3. Total Expenditures forecasted at \$3.7MM, including increase in office expenses, including increases in software purchases, IT, consulting, data services and decreases in nutrition and interest expenses
- 4. Surplus forecasted at \$874K, with a fun ending balance of \$1.3MM
- 5. Cash Balance as of May will be at \$856K, projected at \$694K by fiscal year ending, including \$151K of state Covid Relief grant (SB 86) and AR sales of \$96K deferral financing

Richard Thomas – Our IT expenses are because we went into live instruction in April, especially with our 6-8th graders who use calculators for more complex mathematics. We also added addition of in-person instruction at both campuses.
